Dear friends,

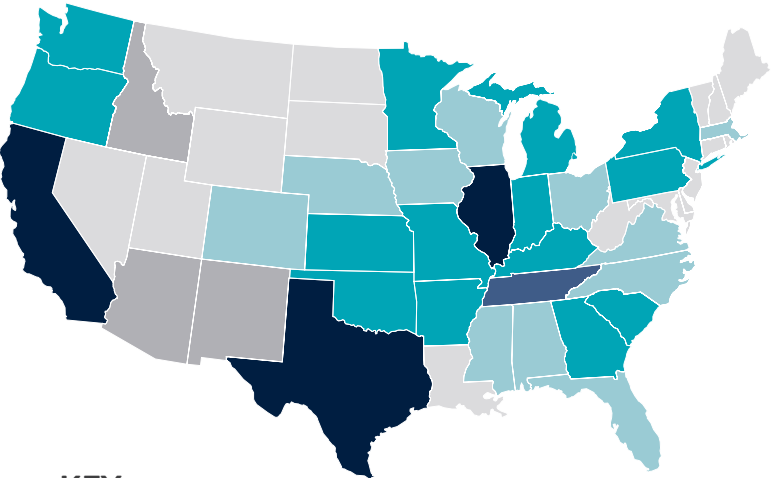

ADVOCACY

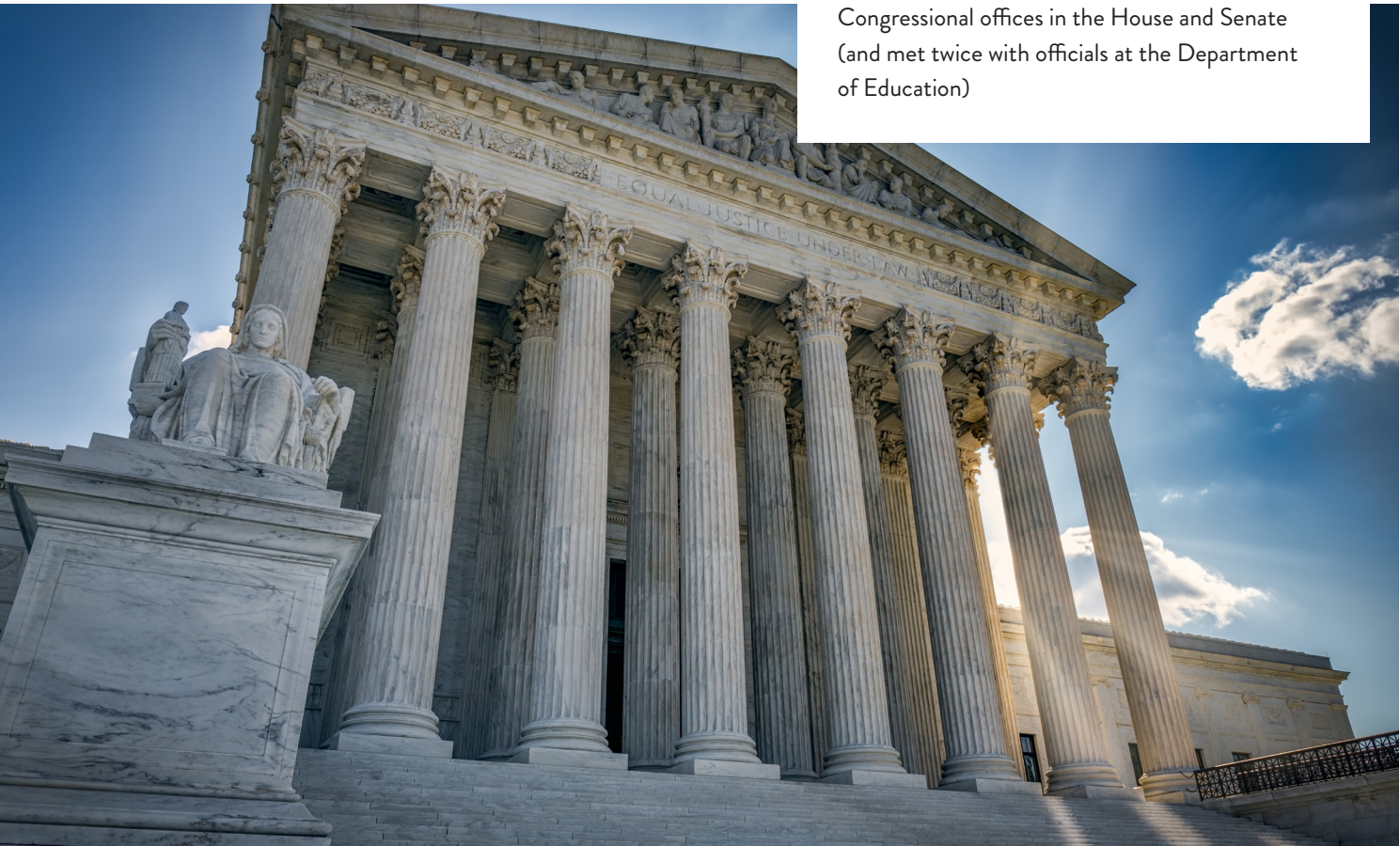
As the leading national voice for Christian higher education, the CCCU aims to be an **effective, respected, and honest advocate for Christ-centered higher education both in the United States and around the world.** The CCCU’s advocacy is primarily centered in the United States, although we represent our international institutions to the U.S. governmental agencies as the need arises. **In all circumstances, the CCCU advocates the right of each of our institutions to practice their sincerely held religious beliefs.** The CCCU is a non-partisan organization striving to work effectively with all political parties to advance the cause of Christ-centered education.

Our Top Advocacy Priorities and Accomplishments This Year Include:



PROTECTING RELIGIOUS MISSION & CONVICTION

We submitted amicus briefs in cases relevant to Christian higher education and continue to engage the Biden administration about proposed Title IX amendments that expand discrimination protections based on sexual orientation, gender identity, sex stereotypes, and sex characteristics.



PROTECTING THE FINANCIAL HEALTH OF OUR INSTITUTIONS

We advocated for doubling the Pell Grant and tax code changes that support tax-free educational assistance benefits.



PROTECTING OUR STUDENTS

We continue to advocate for bipartisan comprehensive immigration reform, including a permanent legislative solution for DACA recipients. In spring 2022, we dispersed \$4,400 in grant funds to seven CCCU institutions across the country to promote conversations and opportunities to think biblically about immigration.



ADVOCACY HIGHLIGHT

2022 Legal and Public Policy Conference

The government relations team convened higher education leaders for the first CCCU Legal and Public Policy Conference since 2016. The conference hosted crucial conversations about ensuring mission fidelity and featured sessions on accreditation, protecting free speech, the upcoming Supreme Court landscape, pending litigation in lower courts, changes to Title IX, and two legal and public relations crisis simulations. Thanks to the positive response and support of our campuses, the CCCU looks forward to hosting this conference again in the future.

PROFESSIONAL DEVELOPMENT

The CCCU equips and empowers campus leaders and faculty in their work through high-quality professional development programs that **develop skills, build connections, and share best practices and new ideas in the face of the challenges and opportunities of the day.** Our conferences and our Leadership Development Institutes play a pivotal role in developing the next generation of Christian higher education leaders by training and equipping a diverse, highly qualified pool of candidates.

RESEARCH & SCHOLARSHIP

Through an array of initiatives, the CCCU promotes the development of high-quality academic research projects and provides opportunities for faculty to conduct innovative research with peers from other campuses. We also provide research on important topics like compensation, retention and graduation rates, and financial health so that administrators can have the most current information for leading highly successful campuses that employ best practices for student thriving and academic success. These projects are designed, developed and managed by the team at SCIO: Scholarship & Christianity In Oxford, the CCCU’s U.K. subsidiary.

INSTITUTIONAL RESEARCH

To help our member institutions gain a better understanding of key metrics and pursue their best path to institutional success, the CCCU has developed a collection of data and reports in a variety of areas. Some are public, while others are confidential for participating members only. This year’s reports included:

- State of STEM
- Campus Diversity Statistics 2021
- Report on Best Practices for Supporting Diversity in STEM Faculty Hiring and Retention at CCCU Institutions
- Campus Responses to COVID-19
- Salary and compensation surveys for faculty and key campus leaders

FACULTY GRANTS

The CCCU enables faculty development and scholarship through institutes and grants intended to help faculty excel in their scholarship and integrate faith into their discipline.

CCCU Networking Grants for Christian Scholars

These grants encourage collaborative scholarship among faculty at CCCU institutions, connecting them with broader networks and supporting high quality scholarship that brings Christian voices into contemporary academic conversations. In 2021-22, a total of \$95,000 was awarded to four projects that included 17 scholars from seven CCCU institutions and two additional institutions.

Supporting Structures: Innovative Collaborations to Enhance STEM Research at CCCU Member Institutions

This three-year, \$2.5M project (launched August 2021) is currently supporting 24 early-career STEM faculty from nine CCCU institutions, enabling them to pursue research by collaborating with major research institutions. It also supports a range of other campus activities geared toward helping campus communities tackle tough questions at the intersection of science and Christian faith and strives to increase faculty diversity in STEM fields.



ADDITIONAL INITIATIVES

- **Council for Collaboration in Doctoral Education** | This council promotes interaction and collaboration for the development and support of doctoral education programs at CCCU institutions. This year, the group held a webinar on Serving in Crisis and hosted its first in-person gathering since 2019.
- **Library Leadership Council** | This new council launched in September 2021 creates opportunities for cooperation and collaboration between libraries at CCCU institutions to take full advantage of knowledge and resources.
- **Logos** | This two-week workshop (made possible by funding from Steve and Jackie Green and offered in cooperation with the Museum of the Bible) provides graduate students and graduating seniors in biblical studies a deep dive into conversations on museums, biblical texts, vocation, and the Christian mind. In 2022, Logos met in Washington, D.C. for the first time. Going forward, it will alternate between D.C. and Oxford (where it has been offered by SCIO since 2013).
- **CAP: Collaborative Assessment Project** | CAP offers CCCU members a common set of campus assessments that provide empirical evidence that Christian higher education is indeed a significant and valuable enterprise. In 2022, CAP is hosted by the Thriving Project at Azusa Pacific University and sponsored by the CCCU. CAP includes a series of webinars for campus leaders to discuss the findings, implications, and potential follow-up actions arising from the data.

PROGRAM HIGHLIGHTS

American Studies Program (Washington, D.C.)

The American Studies Program (ASP) continues to provide students the opportunity to meld classroom learning—course topics last year included developing public policy and examining Christian civility in polarized times—with an extensive internship opportunity in D.C. ASP also welcomed Dr. Doug Koopman, who will serve as the director in residence for 2022-23.

Middle East Studies Program (Amman, Jordan)

The Middle East Studies Program (MESP) gives students the opportunity to experience the daily life, language, food, culture, religion, and politics of a region with ancient roots and modern significance. MESP continues to emphasize helping students understand interfaith relationships and exploring difficult issues in a complex, strategic region, as it has done for 30 years.

Scholarship & Christianity in Oxford (Oxford, United Kingdom)

Scholarship & Christianity in Oxford (SCIO) offers students a chance to study at Oxford, the oldest university in the English-speaking world, and dive into an academic experience steeped in tradition yet on the cutting edge of research and scholarship. SCIO participants join a community of faith engaged in serious learning, affirming their place as Christian scholars dealing with difficult and profound issues in their field of study.



IN THEIR WORDS

“My academic abilities and confidence have skyrocketed. I’ve learned to research more effectively, ask interesting questions, and make nuanced arguments in my essays. The courses and conversations here have helped me realize that I do want to continue my education, that I genuinely love academic work, that I am capable of it, and given me insight into the topics I really love learning about.”

“I think the strength of MESP was the facilitating of hands-on experience of the things we learned [in the classroom]. If it was the Israel-Palestine conflict, we were encouraged to talk to Palestinians about what it means to them. If it was Islam, we were taken to mosques, had guest speakers all over the spectrum of Islam, and read the Quran for ourselves. That approach applied to anything we studied.”

As you’ve seen in this report, the CCCU is hard at work in multiple areas. We advance Christian higher education by defending religious liberty and the critical role Christian education plays in our ever-changing world, fully supporting the belief that all Christian colleges and universities should enjoy the freedom to live out their mission without fear of government intervention. We develop and equip Christian education leaders and link them for greater collaboration, thereby leveraging our resources and impact. As a national association, we take seriously our role of preserving Christianity for the future, to the Glory of God and the good of the world.

As we look back on 2022, we celebrate the many ways our work has impacted Christian higher education:

- Convening 1,500+ Christian leaders at our International Forum, the largest gathering of Christian higher education professionals;
- Advancing religious liberty rights in the courts by submitting amicus briefs to the Supreme Court and other federal courts and letters to Congress, the White House, the Treasury, and the Department of Education;
- Advocating for an increase in Pell Grants that impact 1 out of 3 students at our institutions;
- Equipping the next generation of Christian higher education leaders through our annual Leadership Development Institutes; and
- Defending our institutions in the public square in the ongoing Hunter v. Department of Education case.

We affirm the need to preserve religious liberty and equip current and future Christian leaders. Christian higher education is critical for shaping the next generation to lead and live through the lens of faith. We need these faith-filled leaders to problem-solve with compassion and act for the well-being for

the world out of a love for Jesus Christ. They are, and will be, the redemptive voices in this changing world.

We trust in the Lord’s faithfulness to provide for the future: We could not have achieved these successes without the unwavering support of donors like you, who care deeply about preserving Christianity for the future. As a national association, we will unwaveringly continue to step up to defend and protect our institutions. We need your financial support so we are equipped to respond to the emerging needs of Christian higher education. As good stewards of God’s resources, we have accrued legal fees of the Hunter v. Department of Education instead of our institutions to defend religious exemption on their behalf. Since 2020, we have spent over \$800,000+ in legal fees, which continue to increase.

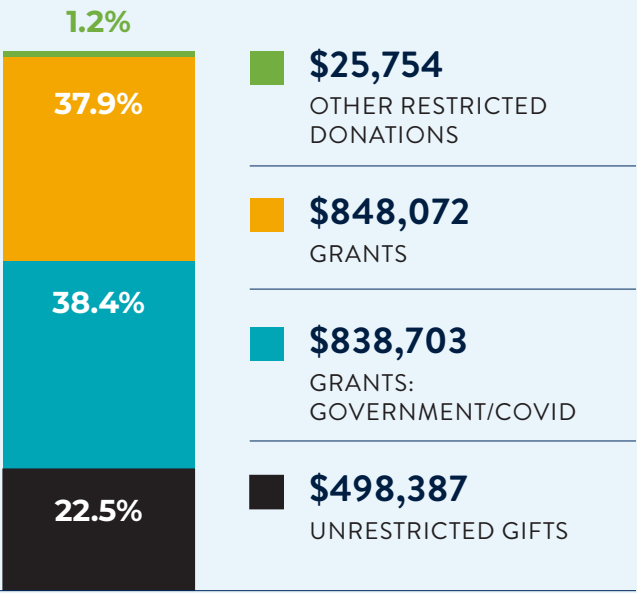

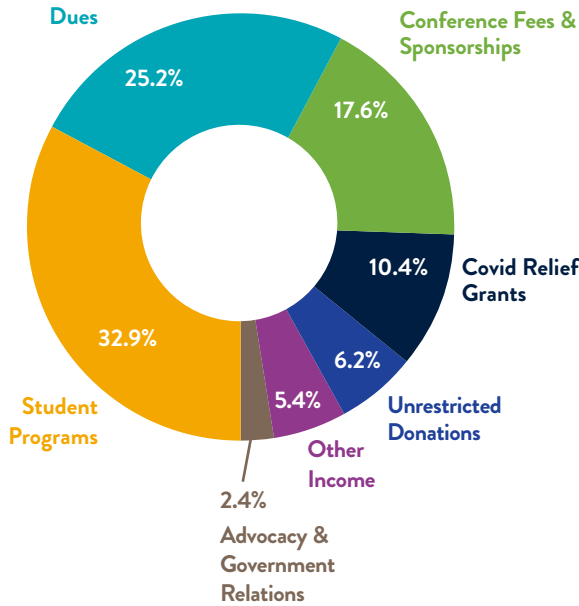

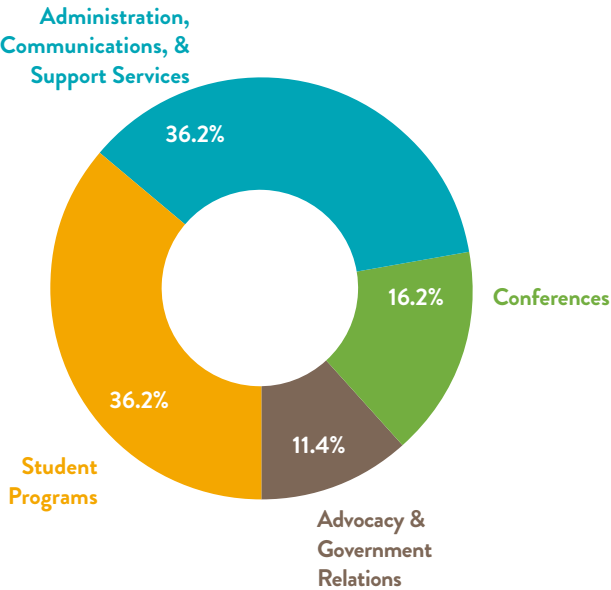

THOUGHT PARTNERS

These partnerships take on various forms to best meet the needs of our member institutions and their communities. Some our partnerships in 2021-22 include:

Kern Family Foundation & Windrider Institute
International Forum Theater Experience

At the CCCU’s International Forum, the Kern Family Foundation and the Windrider Institute partnered with the CCCU to provide the Windrider Theater, a multi-day experience for conference attendees to immerse themselves in short films connected to conference themes, including faith and work, advocacy, and leadership. The Council of Independent Colleges administers the Network for Vocation in Undergraduate Education (NetVUE), a national network of colleges and universities formed to enrich the intellectual and theological exploration of vocation among undergraduates. This partnership reflects a shared belief in the importance of educating future leaders who are theologically literate, whose attitudes and behaviors are shaped by their values and commitments, and who are eager to sustain a life of service that is guided by a sense of calling.

Thanks to the support of the American Immigration Council, the CCCU became part of the Inclusion Innovation Collaborative to support the development and scaling of projects that build more inclusive and welcoming communities across the U.S. After a successful first year, the CCCU received additional funding in May 2021 to fund another cohort of CCCU institutions to participate in the program. Participating institutions created new community partnerships or expanded existing ones; engaged faculty, students, administrators, and community members in developing their engagement and understanding; and developed curriculum and co-curriculum activities as well.
