

CCCU Enrollment Trends Report - Spring 2024

The following report depicts enrollment trends over time for total fall enrollment and fall undergraduate enrollment. The report also presents institutions that have demonstrated growth over time. The data were compiled using a list of Council for Christian Colleges & Universities (CCCU) Governing Member, Associate Member, and Collaborative partner institutions located in the U.S. that were members in the Spring of 2024. All the CCCU data used in this report are from the U.S. Department of Education, National Center for Education Statistics, Integrated Postsecondary Education Data System (IPEDS), 2024, Compare Institutions, Retrieved from https://nces.ed.gov/ipeds/use-the-data on April 19, 2024.




Figure 1: Trends in Total Fall Enrollment

Figure 2: Trends in Average Fall Enrollment






Figure 3: Total Fall Enrollment - National



The following tables list the CCCU U.S. institutions that have displayed growth since 2015. The quartiles were determined using the total fall enrollment in 2022. The criteria used to determine growth is any institution that had higher total fall enrollment in 2022 than 2015, higher total fall undergraduate enrollment between the same years, or both. Some institutions included in the tables below may have decreased in enrollment between 2016 and 2022 but are included because their total enrollment in 2022 is still greater than 2015. The rationale behind using these dates is the decline in average and total undergraduate enrollment for CCCU institutions which began after 2015.

The number of U.S.-based CCCU institutions that are growing in total enrollment is 44 (31% of the sample) and the number growing in undergraduate enrollment is 37 (27% of the sample).
